He stated he received a phone call about a note he supposedly left indicating he had been at fault for vehicular damage. The individual began yelling at him and threatening him for this damage. The RP hung up and called LEO. When he tried to call the individual back, the number wouldn't accept incoming calls.

I explained it sounded like a possible scam where an individual would be threatened into surrendering money for accused wrongs. However, he hung up before the accuser was able to complete the dialogue.

I informed the RP to call back should he be contacted again; but to try and stay on the line longer to get more information so a better understanding of the situation could be gained. I also tried the number and found it inoperable for incoming calls. NFA WH100
